

INFORMATION FORM / RELEASE FORM & PARTICIPANT'S ACKNOWLEDGEMENT OF RISKS

In consideration of the services of Mission Imperative, their officers, agents, and employees, and all other persons or entities associated with those businesses, (including, but not limited to, United Airlines, Airlink, Safair, EAfricaTours, Intercontinental Hotel, Lidiko Lodge, Leopard Mountain Lodge, Kruger Park, Moholoholo Lodge and Rehab. Center, Motswari Lodge, Victoria & Alfred Hotel), hereinafter collectively referred to as "AWS" (African Wildlife Safari), I agree as follows:

- This trip promotes biblical creation and a Christian perspective both to and for the participants, and as a testimony to those outside our group. I agree, therefore, to conduct myself accordingly. I agree not to use language considered to be offensive, nor to wear clothing with graphics considered potentially offensive to others – e.g. alcoholic beverages, graphics or words considered to be suggestive, obscene, etc.
 - I understand that Mission Imperative has the right, and at their own discretion, to make all decisions related to this trip. This will include the participation of any individual/s, and/or anything that might jeopardize the enjoyment or safety of the group.
 - Although AWS has taken reasonable steps to provide me with appropriate equipment & information so I can enjoy an activity for which I may not be skilled, AWS has informed me this activity is not without risk. Certain risks are inherent in each activity and cannot be eliminated without destroying the unique character of the activity. These inherent risks are some of the same elements that contribute to the unique character of this activity and can be the cause of loss or damage to my equipment, or accidental injury, illness, or in extreme cases, permanent trauma or death. AWS does not want to frighten me, but believes it is important for me to know what to expect and to be informed of the inherent risks. The following describes some, but not all, of those risks.
 - Open Land Cruiser Game Drives:** Injury climbing in or out of the vehicle; falling out of the vehicle; vehicle may strike a rock or obstruction; injury from branches; injury by wild animals. (However extremely unlikely these events might be, we must include them.)
 - Game walks:** (Assuming I participate in game walks) - The degree of difficulty for each walk will vary, and there is always a possibility of slipping or falling. Game walks take place in dangerous country. Wild animals are unpredictable where incidents could result in serious injury or death.
- NOTE:* Each person must be aware of his/her physical abilities to walk in a game reserve. It will be the responsibility of each individual to ascertain the nature regarding the specific terrain of each walk/hike proposed and to determine and assume responsibility for all risks involved.
- Schedule:** Riding in an open Land Cruiser, walking, riding in the coach and related activities entail risks of injury or even death to myself or any participant. I understand the description of these inherent risks is not complete and that other unknown or unanticipated inherent risks may result in injury or death. I agree to assume and accept full responsibility for the inherent risks identified herein and those inherent risks not specifically identified. My participation in this activity is purely voluntary, no one is forcing me to participate, and I elect to participate in spite of and with full knowledge of the inherent risks.
 - I acknowledge that engaging in this activity may require a degree of skill and knowledge different than other activities and that I have responsibilities as a participant. I acknowledge that the staff of AWS has been available to more fully explain to me the nature and physical demands of this activity and the inherent risks, hazards, and dangers associated with this activity.
 - I certify that I am fully capable of participating in this activity. Therefore, I assume and accept full responsibility for myself, including all minor children in my care, custody, and control, for bodily injury, death or loss of personal property and expenses as a result of those inherent risks and dangers identified herein and those inherent risks and dangers not specifically identified, or as a result of my negligence in participating in this activity.
 - I have carefully read, clearly understood and accepted the terms and conditions stated herein and acknowledge that this agreement shall be effective and binding upon myself, my heirs, assigns, personal representative and estate and for all members of my family, including minor children.
 - Many of these areas are rural, and issues like weather can possibly shut down roads forcing us to alter the itinerary. I agree to accept whatever changes in the itinerary, though unlikely, might be necessary in the event of conditions beyond human control.
 - I understand that should I cancel the trip once I have booked, I forfeit my deposit unless an alternate can be found to take my place 90 days before departure, or I have covered this expense through trip cancellation insurance. Any cancellation fees are at my expense.
