Due to restrictions in various areas as a result of COVID-19, there might be some activities in the normal itinerary that must be modified or cancelled. SWS has no control over these changes, and will do whatever possible to provide a substitute.				
In the unlikely event that the SWS is cancelled by Mission Imperative for 2021, my deposit will guarantee my place on the SWS for 2022. However, if I request a refund for 2021, then my space on the trip in 2022 is forfeited, and then subject to availability (there are already others on the list for 2021).				
	If I cancel my trip myself, I understand the refund policy as stated in the initial letter I received regarding the SWS for 2021 – "Cancellations with full refund can be made up to 60 days prior to the departure of your trip. After that, and up to 30 days prior to departure, a cancellation will be subject to a 50% refund. No refunds are available for a cancellation within 30 days of departure. Trip cancellation insurance is worth considering if this is a concern."
